ENTRY/DATES: Visit the Visit Yankton website, <https://www.visitanktonsd.com/adventure-giveaway/>, between 12 pm CST, May 1, 2025, and 12 pm CST, April 30, 2026, and enter by filling out the sweepstakes registration form. Limit one entry per person.

ELIGIBILITY: Sweepstakes is open to legal residents of the 50 United States or D.C., ages 18 or older. Employees and officers of VISIT YANKTON are not eligible to enter or win.
